- ∞ Pre-nomination forms are due to the US Lacrosse Chapter All-America Chair from the high school varsity coach, by March 1 for Tier 1 "Early" Chapters, by April 1 for Tier 2 "Mid" Chapters, and by April 20 for Tier 3 "Late" Chapters. All tiers are listed below.
- ∞ No player can be considered for All-American honors if they are not pre-nominated.
- ∞ If a player does not fulfill her commitment to participate in the US Lacrosse Women's Division National Tournament, including participating in every scheduled game, the following penalties will be in effect: Players will not be allowed to be nominated or receive any US Lacrosse Honors (All American or Academic All American and All Star Game) and will not be allowed to participate in the US Lacrosse National Tournament for 1 year.
